INTRODUCTION AND OVERVIEW: The Corps is publishing the current status of mitigation banks (MB) and in-lieu fee (ILF) programs to show if a MB, ILF program, or ILF project allows consideration for Outside of Service Area (OSA) use. The Corps expects this list to change over time as MBs and ILF programs/projects modify their instruments and newer instruments/projects are approved.

The Corps recommends that applicants and agents looking for OSA applicability review the MB or ILF instrument to confirm OSA consideration is included, or contact the Corps Mitigation Section project manager.
